In fiscal year 2009 (ending 30 June) worldwide gross revenues of PwC's network of member firms increased marginally by 0.2% at constant exchange rates to 26.2 billion USD. At variable rates of exchange revenues fell by 7.1%.

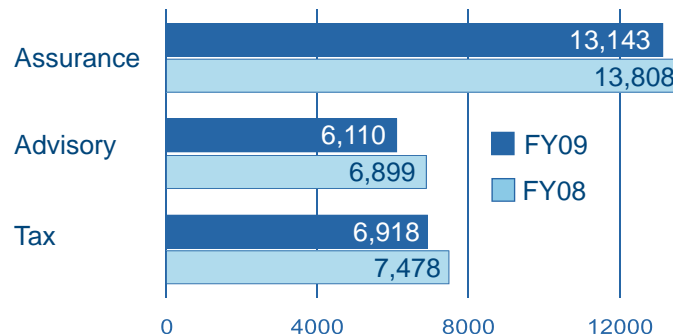
